Dear Fellow Member of the N.C.O.S.,

I relish this opportunity to greet you before the hustle and bustle of the Christmas Season overtakes us. Two other items of business are on my list tonight, but first and foremost, I would like to wish you and all your family a very happy holiday season.

In our recent NCOS mailing to you, a membership reminder form pertaining to this year's delinquent dues was inadvertently included. Instead, it was our intention to include the enclosed 1989 form asking you to remember you Society in your New Year's financial planning. As a nonprofit charitable organisation, contributions will be receipted for income tax purposes.

We spoke in our recent mailing of our forthcoming April 21st Spring Opera Gala. We will work to continue our efforts to keep opera at the forefront of the Canadian cultural agenda, and in particular, National Arts Centre programming. As well, your Board of Directors voted, on your behalf, to devote monies to the support of young persons actively pursuing a future career in opera. We will establish two annual scholarships, of yet-to-be-determined amounts dependent on our fund-raising abilities. The first will be awarded to a young singer, and the second will be designated to assist a trainee aspiring to specialise in backstage opera production. This second area of activity is taught through observation and experience, and there are few accredited courses in the work.

Because of this new thrust of NCOS activity, events such as the April Gala become a major phase of the NCOS year, and your support, either through active organisational participation, or through your attendance, is vital to the success of our undertakings. Films, tours, and corporate donations will augment this enterprise, but we need YOU, your skills and your enthusiasm that arises from our common love of opera.
